ORDER

As recommended by the Registrar of Co-operative Societies, Thiruvananthapuram in the letters read as 7th to 9th papers above, Government are pleased to order the following amendments to the existing Rules for the Constitution and Administration of the Kerala State Co-operative Employees Welfare Board, issued as per Government orders read as 1st to 3th papers above.
